



Dear Crafter:

The Franklin County Agricultural Society will again sponsor its annual Craft Show during the 2010 Franklin County Fair. This will be an excellent opportunity for crafters to display and sell their merchandise as well as give fairgoers the chance to purchase quality, locally produced arts and crafts.

In order to maintain a high level of quality, we have adopted the following criteria for acceptance into the Craft Show. All items must be handcrafted, created or decorated by the crafter. We will not accept foreign or commercially-made products, mass-produced items or handcrafted items purchased for resale. No tag sale or flea market items will be welcome. If you sell any of the items mentioned above, please leave them at home or contact Paul Conway, Franklin County Fair, PO Box 564, Greenfield, MA 01302 for information on renting space outside the craft tent.

The Craft Show will take place on Saturday, September 11 and Sunday September 12, 2010 from 10:00 am to 7:00 pm. Crafters will be located in a large enclosed tent on pavement in the infield of the fairgrounds. Each space is 10 feet by 10 feet. Electricity is available to a limited number. The registration fee for the two days is \$85.00 and is not refundable. We have a raffle to benefit the Franklin County Fair Youth Scholarship Fund and ask that each crafter donate an item. As space is limited, early registration is encouraged.

The tent will be open for crafters at 7:00 am both days and crafters should be ready for business at 10:00 am. Near-by parking will be available. Crafters must supply their own tables and chairs. Break down may not begin before 7:00 pm on Sunday, September 12. There is security at the fairgrounds and there will be overnight security in the craft tent. The decision to leave valuable merchandise overnight is the crafter's. The Franklin County Agricultural Society assumes no responsibility for loss or damage to merchandise or personal property.

Space is available on a first received, first reserved basis. Crafters will be notified upon receipt of application. Foreign or commercially-made products, mass-produced items or items purchased for resale will not be allowed. All items must be handcrafted, created or decorated by the crafter.
